1. Scope

This Privacy Policy explains how JJ Legacy Ventures LLC, doing business as The Jade Ninja ("we," "us"), handles personal information when you visit thejadeninja.com, purchase a subscription through Whop, or join our Telegram channels. By using the Service you consent to this Policy.

2. Information We Collect

- Purchase and account data from Whop: your name, email address, subscription tier, and purchase/renewal history. Payments are processed entirely by Whop and its payment providers - we never receive or store your card or bank numbers.
- Telegram data: your Telegram username/user ID when you join a subscriber channel, and any messages you send to our support or command bot.
- Technical data: standard server logs and basic analytics for our website and dashboards (IP address, browser type, pages viewed, timestamps) used for security and performance.
- Communications you send us (support requests, feedback).

We do not knowingly collect data from anyone under 18, and we do not collect government IDs, brokerage credentials, or trading account data.

3. How We Use Information

- Deliver the Service: grant and manage channel access, match your Telegram account to an active subscription.
- Billing and account management via Whop (renewals, cancellations, billing-error review).
- Support and service announcements (e.g., schedule or policy changes).
- Security, fraud prevention, and enforcement of our Terms (e.g., detecting content redistribution or seat sharing).
- Improving the Service (aggregate, non-identifying usage statistics).
- Compliance with law and lawful requests.

4. How We Share Information

We do not sell personal information, and we do not share it with third parties for their own marketing. We share data only with:

- Service providers that operate the Service: Whop (billing and membership), Telegram (content delivery), our hosting provider, and email/notification providers - each only what they need to perform their function;
- Authorities, when required by law or to protect our rights or users' safety;
- A successor operator, if the Service is sold or reorganized (your data remains subject to this Policy).

5. Data Retention

We keep subscription and access records while your subscription is active and for a reasonable period afterwards for accounting, dispute, and legal purposes, then delete or anonymize them. Server logs rotate on a short cycle.

6. Security

We use reasonable technical and organizational safeguards - access controls, encrypted transport (HTTPS), and least-privilege infrastructure - to protect personal data. No system is perfectly secure; you use the Service at your own risk and should protect your own devices and accounts.

7. International Users

The Service is operated from the United States and data is processed on U.S.-based infrastructure. If you use the Service from elsewhere, you consent to processing in the United States.

8. Your Rights and Choices

- You may request access to, correction of, or deletion of the personal data we hold about you (deleting data required to run an active subscription may require cancelling it).
- You can manage or cancel your subscription and payment profile in your Whop dashboard.
- You can leave our Telegram channels at any time.
- Depending on where you live (e.g., California, EU/UK), you may have additional statutory rights; we honor verified requests as required by applicable law.

9. Cookies and Analytics

thejadeninja.com uses only the cookies and lightweight analytics needed for sessions, security, and understanding aggregate traffic. We do not run third-party advertising trackers.

10. Changes to This Policy

We may update this Policy as the Service evolves. Material changes will be announced in the subscriber channel or via Whop. Continued use after the effective date constitutes acceptance.
