1. Acceptance of These Terms

These Terms of Service ("Terms") are an agreement between you and JJ Legacy Ventures LLC, doing business as The Jade Ninja ("we," "us," "the Service"). By purchasing a subscription through Whop, joining any of our Telegram channels, or using thejadeninja.com or any content we publish, you agree to these Terms, our Privacy Policy, Return Policy, and End User License Agreement (EULA). If you do not agree, do not use the Service. Purchases made on Whop are additionally subject to Whop's own marketplace terms.

2. What the Service Is

The Service publishes algorithmically generated market commentary focused on Nasdaq-100 futures (NQ), including:

- Trade signal alerts (setup type, direction, and reference levels) broadcast to subscriber channels;
- Pre-market daily briefings and post-session recaps;
- Market statistics, dashboards, and educational material.

All Content is delivered on an impersonal, broadcast basis: every subscriber at a given tier receives the same Content at the same time. We never provide one-on-one trade recommendations, account management, or advice tailored to you.

3. Not Investment Advice; Publisher Status

All content provided by the Service - including trade alerts, signals, daily briefings, market commentary, statistics, charts, and educational material (collectively, "Content") - is impersonal, general-audience information published simultaneously to all subscribers. It is NOT investment, financial, legal, or tax advice, is not tailored to any person's circumstances, and is not a recommendation to buy or sell any security, futures contract, or other instrument. JJ Legacy Ventures LLC, doing business as The Jade Ninja, is a publisher. We are not registered as a Commodity Trading Advisor with the CFTC, in reliance on the publisher's exemption in CFTC Rule 4.14(a)(9), and we are not registered as an investment adviser or broker-dealer with the SEC or any state. We do not manage accounts, execute trades for you, or provide personalized recommendations. - Subscriptions renew automatically each billing period until cancelled.
- You may cancel at any time through your Whop dashboard. Cancellation stops future renewals; access continues through the end of the period already paid.
- Prices may change; changes apply from the next renewal after notice.
- All payments are final. Refunds cannot be requested. See the Return Policy (3-day billing-error window) for the only exceptions we review.

8. Acceptable Use

You agree NOT to:
