

## High Five Collective — End User License Agreement (EULA)

Effective Date: Jan. 18<sup>th</sup> 2026

This End User License Agreement (“EULA”) is a legal agreement between you (“User,” “you”) and [Your Legal Entity Name] (“Company,” “we,” “us”), governing your access to and use of the High Five Collective community, content, tools, alerts, educational resources, websites, and related services (collectively, the “Service”).

By purchasing, accessing, or using the Service, you agree to be bound by this EULA.

### 1. License Grant (Limited, Revocable)

Subject to your compliance with this EULA, the Company grants you a limited, revocable, non-exclusive, non-transferable, non-sublicensable license to access and use the Service solely for your personal, non-commercial use during an active subscription term (if applicable).

No ownership rights are transferred to you. The Service is licensed, not sold.

### 2. Account & Access Rules

You agree that:

- You are responsible for maintaining the confidentiality of your login credentials.
- You will not share accounts, logins, invite links, or access methods with any other person.
- You are responsible for all activity occurring under your account.

We may use reasonable methods (including access logs) to detect abuse, sharing, or unauthorized use.

### 3. Restrictions (Zero Tolerance)

You agree you will not, directly or indirectly:

#### A) No Redistribution / Sharing / “Leak” Behavior

- Copy, record, download (where not explicitly permitted), reproduce, distribute, republish, upload, post, transmit, or disseminate any portion of the Service

(including Discord content, videos, PDFs, charts, alerts, templates, indicators, bots, watchlists, commentary, or screenshots) outside the community without written permission.

- Share the Service or any portion of it with non-members, including via screen recordings, screen sharing, file sharing, or “recap” posts that meaningfully reproduce the content.

#### B) No Resale / No Commercial Use / No Solicitation

- Resell, rent, lease, sublicense, “group buy,” monetize, or commercially exploit the Service or any content.
- Solicit, advertise, market, promote, or sell products/services to members (including coaching, signals, courses, indicators, referral links, affiliate offers, paid groups, or competing communities) without the Company’s prior written consent.

#### C) No Sharing Other Creators’ Content

- Post, distribute, or promote other creators’ paid, private, copyrighted, or pirated content inside or outside the community (including paid courses, paywalled Discord posts, premium indicator files, PDFs, recordings, or proprietary materials) unless you have explicit permission from the rights holder.

#### D) No Reverse Engineering / Tampering

- Modify, reverse engineer, decompile, disassemble, bypass, or attempt to derive source code or underlying methods of the Service or related tools, including any software or automation components.

#### E) No Unlawful or Harmful Use

- Use the Service for illegal, fraudulent, abusive, harassing, defamatory, hateful, or otherwise harmful activities.
- Attempt to disrupt, overload, or compromise the Service or community operations.

## 4. Intellectual Property

All content and materials within the Service—including text, graphics, logos, trademarks, videos, audio, charts, templates, indicators, software, trade frameworks,

and educational resources—are owned by the Company or its licensors and are protected by copyright, trademark, and other intellectual property laws.

You receive no rights except the limited license in Section 1.

## 5. No Financial Advice / Risk Disclosure

### a. Educational Only (No Advice):

Nothing in the Service constitutes financial, investment, tax, or legal advice. Content is provided for educational and informational purposes only.

### b. Risk of Loss:

Trading and investing involve substantial risk, including the possible loss of all capital. You are solely responsible for your decisions, risk management, and outcomes.

### c. No Guarantees:

We do not guarantee results, profitability, accuracy, completeness, timeliness, or suitability of any content.

## 6. Termination (Immediate + No Refund)

This EULA remains effective until terminated.

We may suspend or terminate your access to the Service at any time, with or without notice, if we determine in our sole discretion that you:

- violated this EULA or community rules,
- shared or redistributed content (ours or others'),
- attempted to sell/promote products/services to members without permission,
- engaged in harassment, spam, fraud, or disruptive conduct, or
- used chargebacks/disputes abusively.

Upon termination, you must immediately cease all use of the Service and delete/discontinue any copies or exports of content in your possession.

Termination is in addition to any other rights or remedies we may have, and may be enforced without refund where permitted by law.

## 7. Enforcement & Injunctive Relief

Unauthorized sharing, resale, or dissemination of content may cause irreparable harm. You agree the Company may seek injunctive relief (court order) and other remedies, in addition to damages, without needing to post a bond where permitted.

## 8. Disclaimer of Warranties

The Service is provided on an “AS IS” and “AS AVAILABLE” basis. To the maximum extent permitted by law, the Company disclaims all warranties, express or implied, including merchantability, fitness for a particular purpose, and non-infringement.

## 9. Limitation of Liability

To the maximum extent permitted by law, in no event will the Company be liable for any indirect, incidental, special, consequential, exemplary, or punitive damages, or any loss of profits, data, goodwill, or business opportunities arising from or related to your use of (or inability to use) the Service.

If liability cannot be fully excluded, our total liability will not exceed the amount you paid to the Company for the Service in the most recent one (1) month (or the minimum amount allowed by law, if greater).

## 10. Third-Party Platforms & Tools

The Service may be delivered through third-party platforms (e.g., Discord, payment processors, charting/broker tools). We are not responsible for third-party outages, interruptions, errors, bans, delays, or policy changes.

## 11. Governing Law
