

End User License Agreement

ProfitHub Trading

Digital Content License for ProfitHub Trading calls, recordings, Discord content, strategies, indicators, tools, and educational materials.

Personal-Use License Only

Your membership gives you a limited right to study ProfitHub materials for your own personal trading education. You may not record, share, repost, resell, teach, scrape, clone, reverse engineer, or use the materials to build a competing product or community.

1. Agreement and Relationship to Other Policies

This End User License Agreement and Digital Content License ("EULA") is between you and ProfitHub Trading, operating under the SeanDayTrades brand ("ProfitHub"). It applies when you access or receive any licensed material through the ProfitHub membership.

The Terms of Service, Privacy Policy, and Refund Policy also apply. If this EULA conflicts with the Terms of Service concerning ownership or use of licensed material, the provision that gives ProfitHub greater protection will control to the extent permitted by law.

2. Licensed Materials

"Materials" include all content made available through or in connection with the Service, including live calls, audio and video recordings, replays, Discord messages, charts, screenshots, annotations, trade reviews, backtests, strategies, models, terminology, checklists, PDFs, documents, presentations, templates, images, databases, indicators, scripts, code, software, tools, downloadable files, course organization, and compilations, whether created by ProfitHub or licensed from another party.

3. License Grant

Subject to payment and compliance with all policies, ProfitHub grants you a limited, revocable, non-exclusive, non-transferable, non-sublicensable license to access and use the Materials solely for your personal, non-commercial trading education.

Access to hosted Materials ordinarily lasts only while your membership is active. A file expressly made available for download may be retained after cancellation for private study unless the file states otherwise or your access was terminated for breach. No right to updates, support, future recordings, or continued platform access survives cancellation.

4. Ownership and Reservation of Rights

ProfitHub and its licensors retain all ownership and intellectual property rights in the Materials, including copyrights, trademarks, trade dress, trade secrets, database rights, and rights in selection,

arrangement, and presentation. The license is permission to use the Materials, not a sale or transfer of ownership.

ProfitHub Trading, SeanDayTrades, associated logos, course names, strategy names, and distinctive branding may not be used in a manner that suggests affiliation, endorsement, or ownership without written permission.

5. Prohibited Uses

Unless ProfitHub gives prior written permission, you may not engage in any of the following:

- Record, screen-record, photograph, capture, download through unauthorized means, or reproduce a live call, replay, channel, direct message, or protected screen.
- Share, forward, publish, display, broadcast, upload, leak, distribute, sell, rent, license, sublicense, gift, or transfer Materials or membership access to another person.
- Post Materials on social media, another Discord server, a file-sharing site, a course platform, a group chat, an AI service, a public repository, or any other external system.
- Use Materials to operate, market, or improve a competing mentorship, paid group, signal service, course, indicator package, software product, backtesting product, or educational business.
- Teach or present ProfitHub strategies or Materials as your own, remove ownership notices, or falsely claim authorship or affiliation.
- Scrape, archive, index, data-mine, systematically copy, or use bots, browser automation, or extraction tools to collect Materials or member information.

- Use Materials, recordings, transcripts, or messages to train, fine-tune, evaluate, or populate an artificial-intelligence model, dataset, knowledge base, or automated advisory product.
- Share login credentials, Discord roles, invite links, access tokens, API credentials, or downloaded Materials with any other person.
- Use another member's charts, messages, voice, image, results, or personal information outside the community without permission.

6. Calls, Recordings, and No Member Recording

ProfitHub may record sessions after providing notice and may place authorized recordings in the private member library. By joining and remaining after notice, you consent to recording of your voluntary voice, screen name, chat messages, screen share, and contributions for operation of the Service.

Your consent for ProfitHub to create an authorized recording does not give you permission to create your own recording. Members may not secretly record or rebroadcast calls, direct messages, or voice communications. If you do not consent to an authorized ProfitHub recording, do not speak, enable video, share a screen, or post in that recorded session.

7. Member Notes and Limited Quotations

You may create private handwritten or typed notes summarizing concepts for your own study. You may not create or distribute a near-verbatim transcript, substitute course, comprehensive reproduction, or collection that could replace the membership.

Brief quotations for legitimate commentary may be allowed only to the extent required by applicable law. This EULA does not eliminate rights that cannot lawfully be waived, but it does prohibit using a legal exception as a pretext to redistribute the core value of the Service.

8. Third-Party Materials and Software

Some Materials may include or reference third-party software, data, charts, marks, or content. Those items remain subject to the third party's license and terms. Nothing in this EULA grants rights that ProfitHub does not own or have authority to license.

9. Updates, Changes, and Access Controls

ProfitHub may update, replace, remove, watermark, limit, or disable Materials and may use access logs or technical controls to protect them. Features may change without creating an obligation to maintain an older version. Attempts to bypass access controls are a material breach.

10. Reporting Infringement

If you believe ProfitHub Materials are being shared, copied, impersonated, or sold without permission, contact SeanDayTrades@gmail.com with links, screenshots, usernames, dates, and other relevant information. Do not place yourself or another person at risk to gather evidence.

11. Suspension and Termination of License

The license ends automatically when your membership ends for hosted Materials, when you violate this EULA, or when ProfitHub gives notice of termination. ProfitHub may immediately suspend access and require deletion of downloaded Materials after a serious or repeated breach.

Upon termination for breach, you must stop using the Materials and delete copies in your possession or control, except records you are legally required to retain. Termination does not limit ProfitHub's right to seek injunctive relief, damages, platform enforcement, or other remedies.

This statement does not create a predetermined penalty or limit any defense available under law.

14. Governing Law and General Terms

This EULA is governed by Florida law, subject to non-waivable law. The dispute, severability, waiver, assignment, electronic acceptance, and modification provisions in the Terms of Service are incorporated into this EULA.

If any restriction is found unenforceable, it will be enforced to the maximum lawful extent, and the remaining provisions will continue. No waiver is effective unless in writing by ProfitHub.
