

Refund Policy

ProfitHub Trading

Effective date: July 14, 2026

This policy explains the no-refund terms for the ProfitHub Trading monthly membership.

No-Refund Rule

All \$69.99 monthly membership charges are final and non-refundable, except where applicable law requires otherwise. Cancel before the next renewal date to stop future charges. Cancellation does not reverse a charge that has already been processed.

1. Monthly Membership

ProfitHub Trading is a recurring digital membership providing access to a private Discord community, calls, recordings, educational material, backtesting, feedback, and related support. Access is delivered after successful payment and normally continues for the paid billing period.

2. No Refunds or Prorated Credits

All charges are non-refundable and non-creditable. ProfitHub does not provide full or partial refunds, prorated refunds, retroactive credits, extensions, or account transfers merely because a member did not use the Service or did not obtain the result expected.

3. Situations That Do Not Qualify for a Refund

- Missing, skipping, or being unable to attend a live call.
- Failing to use the Discord, recordings, backtesting sessions, feedback, or personal help.
- Scheduling conflicts, travel, work, school, illness, time-zone differences, or market holidays.
- Dissatisfaction with educational style, community activity, call timing, or the amount of personal participation.
- Trading losses, a failed evaluation, a denied payout, account-rule violations, or failure to become profitable.
- Forgetting to cancel before the renewal date or failing to complete the platform cancellation process.
- A change in financial circumstances, available capital, broker, proprietary trading firm, platform, or strategy preference.
- Suspension or termination for nonpayment, chargeback, account sharing, harassment, content theft, or another violation of the Terms.

4. Cancellation of Future Renewals

You may cancel through the account, checkout, or membership platform used to subscribe. When platform cancellation is not available, contact ProfitHub at the email below. Cancel before the next renewal charge to avoid that charge.

Cancellation stops future automatic renewals. Unless access is terminated for a violation, you will ordinarily retain access through the end of the already-paid billing period. Unused time is not refundable.

5. Limited Exceptions

ProfitHub will review a written request concerning a verified duplicate charge, a clear billing error, or an unauthorized transaction. Contact us promptly and provide the transaction date, amount, account email, and relevant documentation. Approval is not guaranteed unless required by law.

Nothing in this policy limits a non-waivable consumer right or refund required by applicable law. When a law requires a refund, ProfitHub will provide the remedy required by that law and no more.

6. Chargebacks and Payment Disputes

Before initiating a chargeback, contact SeanDayTrades@gmail.com so the issue can be reviewed. A chargeback does not automatically establish that a charge was improper. ProfitHub may provide the payment processor with the purchase record, acceptance of policies, access logs, cancellation status, and relevant communications.

A chargeback, reversed payment, or payment dispute may result in immediate suspension or termination of access. ProfitHub reserves the right to recover unpaid amounts and reasonable costs where permitted by law. This section does not prevent a member from disputing a genuinely unauthorized or unlawful charge.

7. Platform Processing Times

When a refund is required or voluntarily approved, it will be returned through the original payment method when practical. Banks and payment processors control posting times, which may take several business days or longer. ProfitHub cannot accelerate a third party's processing time.

8. Policy Changes

ProfitHub may update this Refund Policy for future purchases or renewals. The version in effect when a charge is processed will generally govern that charge, subject to applicable law and any separately disclosed change.
