

## PRIVACY POLICY

We do not collect:

Cookies

Tracking pixels

Behavioral or analytics data

IP-based tracking for marketing purposes

### 2. HOW WE COLLECT INFORMATION

We collect personal information when you:

Apply for or purchase our programs or services

Communicate with us for inquiries, consultations, or support

### 3. HOW WE USE YOUR INFORMATION

We use your personal information for the following purposes:
