

END USER LICENSE AGREEMENT (EULA)

1. License Grant

2. License Restrictions

You shall not, and shall not allow any third party to:

- use the Software, its outputs, or anything derived from it to build, train, operate, market, or improve any competing product, service, or dataset;
- share, transfer, or relay your access or credentials, or use the Software on behalf of others or a business team without authorization; or
- remove or alter any proprietary notice, or circumvent any access control, rate limit, or security measure.

3. Ownership
