6-Figure Creator - Terms of Service

Last Updated: July 30, 2026

By purchasing a membership, purchasing or registering for an event, or entering or attending an event hosted, produced, or organized by 6-Figure Creator ("6FC") operated by Live Commerce Agency LLC, you agree to the following Terms of Service ("Terms"). These Terms apply to purchasers, members, registrants, attendees, guests, and plus-ones, as applicable. If you do not agree, do not complete your purchase, registration, or event entry.

1. Nature of the Membership and Events

6-Figure Creator is an educational membership community providing training, resources, community access, coaching opportunities, and in-person or virtual events for creators.

Membership benefits may include:

- Educational content and live or recorded trainings
- Community access, including Discord or similar platforms
- Optional access to promotional product samples
- Temporary or ongoing access to 6FC tools and resources depending on membership level
- Eligibility to purchase or attend in-person events, workshops, conferences, dinners, networking activities, or similar experiences

6FC does not guarantee income, results, brand partnerships, platform approvals, financial outcomes, or any particular experience, speaker, agenda, or result from an event.

2. No Earnings or Results Guarantees

You acknowledge and agree that:

- Results vary based on individual effort, consistency, experience, and platform conditions
- Any earnings or success examples shared are illustrative only and not guarantees

- TikTok, TikTok Shop, and other platforms operate independently and may change policies or algorithms at any time

You are solely responsible for your results.

3. Membership Billing & Cancellation

3.1 Initial Purchase

Your initial membership purchase grants immediate access to digital content and the 6FC community for the duration specified in the product description at the time of purchase. Access does not extend beyond that stated term unless otherwise explicitly provided in writing by 6-Figure Creator.

3.2 Recurring Membership

If your membership includes a \$99/month recurring plan, you may cancel future billing at any time directly through your Whop account.

- Cancellation stops future charges only
- Previously billed amounts are not retroactively refunded, except as expressly outlined in these Terms
- Access continues through the end of the current billing period

4. Refund Policy

6-Figure Creator aims to be transparent and reasonable. Refund eligibility depends on the product or service purchased and the terms below.

4.1 Community Access and Coaching - Refund Eligibility

Refund requests for the initial Community Access and Coaching payment may be considered only if all of the following are true:

- The request is submitted within 7 days from the date of purchase
- The member has not completed a product sample request form
- The member has not received access to promotional product samples

Refund requests submitted after 7 days from the date of purchase will not be eligible for consideration.

4.2 Sample Access & Refund Cutoff

Once a member completes a product sample request form or receives access to promotional product samples, the initial Community Access and Coaching payment becomes permanently non-refundable, even if the 7-day period has not yet expired.

This is due to the non-returnable and promotional nature of product samples and the value delivered once samples are allocated.

4.3 Non-Refundable Community Circumstances

Refunds for Community Access and Coaching will not be issued for:

- Members who have requested or received product samples
- Failure to participate or fully utilize the membership
- Platform account issues, suspensions, restrictions, or content performance
- Dissatisfaction with results or expectations
- Personal scheduling conflicts or circumstances
- Changes to third-party platforms

4.4 In-Person Event Tickets

All purchases of tickets, admission packages, VIP upgrades, deposits, event add-ons, and applicable processing fees for in-person events hosted, produced, or organized by 6-Figure Creator are final and non-refundable upon purchase, except if 6-Figure Creator cancels the event outright and does not reschedule it, or where otherwise required by applicable law.

Attendee Cancellations and No-Shows. Refunds will not be issued when an attendee cancels or cannot attend because of illness, medical circumstances, scheduling conflicts, personal or family circumstances, transportation or travel issues, failure to make or complete travel arrangements, or any other reason outside 6FC's control. Failure to attend or check in does not create refund eligibility.

Event Changes. 6FC may make reasonable changes to the event's speakers, coaches, agenda, activities, schedule, timing, venue, or format. Such changes do not constitute cancellation and do not entitle the purchaser to a refund.

Postponement and Rescheduling. If an event is postponed or rescheduled, the ticket and any eligible 6FC-sold event add-ons will automatically remain valid for the replacement date. A postponement or rescheduling does not create refund eligibility.

Ticket Transfers. A ticket may be transferred one time to another attendee if the purchaser provides written notice before the transfer deadline communicated for the event and complies with any event-specific transfer instructions. Transfers are subject to 6FC's confirmation and do not entitle the original purchaser to a refund.

Force Majeure. If circumstances beyond 6FC's reasonable control, including severe weather, natural disasters, government orders or restrictions, public-health emergencies, venue unavailability, transportation disruptions, labor interruptions, or similar events, require 6FC to postpone, relocate, or reschedule the event, tickets will remain valid and non-refundable. If 6FC instead cancels the event outright and does not reschedule it, the cancellation terms below will apply.

Travel and Accommodation. Attendees are solely responsible for airfare, lodging, transportation, meals, visas, lost wages, and all other expenses associated with attending. 6FC is not responsible for reimbursing or compensating any third-party or incidental expenses, even if the event is postponed, relocated, rescheduled, or canceled.

Removal from Event. An attendee who is denied entry or removed for violating event rules, safety requirements, applicable law, venue policies, or the 6FC code of conduct will not be entitled to a refund.

Cancellation by 6FC. If 6FC cancels an event outright and does not reschedule it, the purchaser will be entitled to a refund of the amount paid directly to 6FC for the event ticket, admission package, deposit, VIP upgrade, and eligible 6FC-sold event add-ons. Refunds will not include airfare, lodging, transportation, lost wages, third-party purchases, or non-refundable processing fees where permitted by law. This is the only circumstance in which an event-ticket refund will be issued, except where otherwise required by applicable law.

5. Product Samples Disclaimer

- Product samples are provided for promotional and educational purposes only
- Sample retail values are estimated and may vary
- Sample availability, quantities, and specific items are not guaranteed
- Samples are non-returnable and non-exchangeable

Access to or receipt of samples constitutes meaningful value delivered as part of the membership.

Sample Delivery:

- The Sample Box Starter Kit and all samples available to 6-Figure Creator members will only be shipped to members with an address in the United States

6. Event Photography, Recording & Publicity Release

6.1 Recording Notice

By registering for, purchasing a ticket to, entering, or attending an in-person event hosted, produced, or organized by 6FC, you acknowledge that photography, video recording, livestreaming, and audio recording may occur throughout event spaces, activities, sessions, and common areas.

6.2 Consent and License

To the maximum extent permitted by applicable law, each adult attendee grants 6FC operated by Live Commerce Agency LLC, and their affiliates, contractors, photographers, videographers, agencies, licensees, successors, assigns, platforms, and service providers a worldwide, perpetual, royalty-free license to photograph, film, record, edit, reproduce, publish, display, distribute, broadcast, stream, advertise, and otherwise use the attendee's name, image, likeness, voice, appearance, statements, and participation in connection with lawful marketing, advertising, promotional, educational, editorial, archival, and social-media purposes, in any media now known or later developed.

6.3 Approval, Compensation, and Ownership

Adult attendees waive any right to inspect or approve the final materials and acknowledge that no additional approval, payment, royalty, or other compensation will be owed for permitted uses. Recordings and materials created by or for 6FC will be owned or controlled by 6FC or the applicable content owner. 6FC will not knowingly use an attendee's image, likeness, voice, or statements in a defamatory or materially misleading manner.

6.4 Guests and Plus-Ones

Ticket purchasers are responsible for providing these Terms to their guests and plus-ones before attendance. Each guest or plus-one may be required to complete a separate registration, acknowledgment, or release at or before event check-in. A purchaser may not grant publicity rights on behalf of another adult attendee unless legally authorized to do so.

6.5 Attendees Under 18

An attendee under 18 years of age may not independently grant the rights described in this Section. A parent or legal guardian must authorize the minor's attendance, accept any event terms applicable to the minor, and complete any separate written consent or release required by 6FC.

6FC will not knowingly feature an identifiable minor as the subject of marketing or advertising materials unless the minor's parent or legal guardian has provided express written consent. General crowd, background, or incidental footage may be captured where permitted by law. A parent or legal guardian is responsible for supervising the minor and notifying 6FC event staff of any applicable restriction before the event or at check-in.

6FC may deny event entry to a minor when required guardian consent, supervision, identification, or event-specific documentation has not been provided. Any refund eligibility will remain governed by Section 4.4 and applicable law.

7. Platform & Third-Party Disclaimer

6-Figure Creator is not affiliated with or responsible for TikTok, TikTok Shop, or any third-party platform.

You acknowledge that:

- Accounts may be restricted, suspended, or removed by platforms at their discretion
- Content visibility, monetization, and reach are not guaranteed
- Platform rules and algorithms may change without notice

6FC is not responsible for platform enforcement actions.

8. Health & Product Use Disclaimer

Any discussion of health, wellness, or product usage is provided for educational purposes only and does not constitute medical advice.

You are responsible for:

- Following manufacturer instructions

- Using products safely and as intended
- Consulting qualified professionals when appropriate

9. Community and Event Conduct & Access

6-Figure Creator reserves the right to limit, suspend, remove, or deny access to a community, membership, or event for conduct that is:

- Disruptive, unsafe, or threatening
- Abusive, discriminatory, or harassing
- Fraudulent or misleading
- In violation of community guidelines, event rules, venue policies, safety requirements, or applicable law

Removal from the community or an event for conduct violations does not automatically entitle the member, purchaser, or attendee to a refund.

10. Whop Payments & Disputes

All payments are processed through Whop unless otherwise stated at checkout.

By purchasing, you acknowledge that:

- Access to digital content and the community may be delivered immediately
- In-person event tickets are non-refundable except as expressly stated in Section 4.4
- Filing a chargeback or payment dispute after access, sample allocation, or event-ticket purchase may result in removal of access, cancellation of event admission, or permanent account restriction
- 6FC may submit access logs, timestamps, transaction records, ticket and attendance records, communications, accepted purchase terms, and usage data to Whop or the payment processor to resolve disputes

Disputes are handled in accordance with Whop's platform policies and applicable law.

11. Limitation of Liability

To the maximum extent permitted by law, 6-Figure Creator shall not be liable for indirect, incidental, special, or consequential damages, including travel expenses, lodging expenses, lost wages, lost profits, or other third-party costs associated with a membership, product, or event.

To the maximum extent permitted by law, total liability shall not exceed the amount paid directly to 6FC for the membership, product, or event ticket giving rise to the claim.

12. Governing Law

These Terms are governed by the laws of the state in which Live Commerce Agency LLC is registered, without regard to conflict-of-law principles, except where applicable law requires otherwise.

13. Acknowledgment

By completing a purchase or registration, or by attending an event, you acknowledge that you:

- Understand that 6FC provides educational memberships, resources, coaching opportunities, and events
- Understand results and income are not guaranteed
- Understand you may cancel future monthly membership billing at any time
- Understand Community Access and Coaching refunds are no longer available once product samples are requested or accessed or after 7 days from the date of purchase
- Understand that in-person event purchases are final and non-refundable except if 6FC cancels the event outright and does not reschedule it
- Understand that postponement, rescheduling, relocation, or reasonable event changes do not create refund eligibility
- Understand that 6FC is not responsible for travel, lodging, transportation, lost wages, or other third-party expenses associated with event attendance
- Understand that photography, video recording, livestreaming, and audio recording may occur at 6FC events and agree to the applicable event-media terms in Section 6

- Confirm that you are at least 18 years old, or that a parent or legal guardian will provide any consent required for a minor attendee
- Agree to these Terms in full

Checkout Acknowledgment

I understand that I may request a refund for Community Access and Coaching within 7 days from the date of purchase, provided I have not completed a product sample request form or received access to promotional product samples.

I understand that once I request or receive product samples, my Community Access and Coaching purchase becomes permanently non-refundable.

I understand that I may cancel my \$99/month membership at any time to stop future billing, but previously billed amounts are non-refundable.

I understand that all in-person event ticket purchases, admission packages, VIP upgrades, deposits, event add-ons, and applicable processing fees are final and non-refundable upon purchase. The only circumstance in which 6FC will issue an event-ticket refund is when 6FC cancels the event outright and does not reschedule it, except where otherwise required by applicable law.

I understand that event postponement, rescheduling, relocation, speaker or agenda changes, personal inability to attend, and no-shows do not create refund eligibility, and that 6FC is not responsible for airfare, lodging, transportation, lost wages, or other third-party expenses.

By registering for, purchasing a ticket to, entering, or attending a 6FC event, I acknowledge that photography, video recording, livestreaming, and audio recording may occur. If I am an adult attendee, I consent to the use of my name, image, likeness, voice, appearance, statements, and participation as described in Section 6, without further approval or compensation.

I confirm that I am at least 18 years old. If I am registering for or accompanying an attendee under 18, I confirm that I am the attendee's parent or legal guardian, or otherwise have legal authority to act on the attendee's behalf, and I agree to complete any separate written consent or release required by 6FC before the minor is knowingly featured in marketing or advertising materials.
