Payment Information: payments are processed by Whop and its payment processors. We typically do not store full payment card details.

Usage Data: log data such as access times, device/browser information, and interactions with content.

Analytics & Tracking: we may use analytics tools and pixels to understand performance and improve the Services.

3. How We Use Your Information

We use information to:

Provide and operate the Services, including delivering access to content and community features.

Communicate with you about your subscription, updates, announcements, and support requests.

Prevent fraud, abuse, unauthorized sharing, and policy violations.

Improve our educational content, community experience, and Store performance.

Comply with legal obligations and enforce our Terms.

4. How We Share Information

We may share information with:

Whop: to provide the Store, billing, and subscription management.

Discord: to enable community access and participation.

Service Providers: analytics, email delivery, and operational tools that help us run the Services.

Legal/Compliance: if required by law or to protect our rights, users, or the public.

We do not sell your personal information as a standalone business model.

5. Data Retention

We retain personal information only as long as necessary to provide the Services, comply with legal obligations, resolve disputes, and enforce agreements.
