Article I – Introductory Provisions

1. These Terms and Conditions govern the rights and obligations between the provider (Monyxo Digital s.r.o.) and the purchaser of the digital product The Theme Page Protocol Bundle 2.0 (hereinafter the “Service”).
2. The Service means access to digital content - e-books, templates, editing bundle and other tools - intended to support growth on social media without showing one’s face.
3. By purchasing the Service, the user confirms that they have read these Terms and Conditions and agree to their wording.

Article II – Licence and Use
