We do **not** operate a standalone website for user registration or checkout.

2. THIRD-PARTY PLATFORMS (IMPORTANT)

We sell access to our services through **Whop.com** ("**Whop**"). Whop acts as a third-party platform that manages:

- Customer accounts
- Payment processing

Any personal information collected by Whop is processed according to **Whop's own Privacy Policy**. We do not receive or store full payment card details or sensitive financial information.

Our community is hosted on **Discord**, which independently collects and processes certain user data under its own privacy policy.

We may receive the following information when you use our Services:

- Subscription status and plan tier (via Whop)

- Information you voluntarily share in our Discord community

Payments are processed by **Whop and its payment processors**. We do not collect or store:

- Credit or debit card numbers
