

END USER LICENSE AGREEMENT (EULA)

1. Agreement

This End User License Agreement ("Agreement") governs the use of audio mixing and mastering services provided. By purchasing or using these services, you agree to be bound by this Agreement.

2. License Grant

Upon full payment, you are granted a non-exclusive, non-transferable license to use the final delivered audio files for personal or commercial purposes, subject to the terms of this Agreement.

3. Ownership

You retain full ownership of your original recordings. The service provider retains ownership of any proprietary techniques, processing chains, or internal production methods used to complete the service.

4. Restrictions

You may not claim ownership of any proprietary production methods. You may not resell, redistribute, or transfer unfinished or draft versions of the project.

5. Delivery & Acceptance

Final audio files are considered accepted once delivered unless a revision request is submitted within the agreed revision period.

6. Revisions

Revisions are limited to the number specified in the purchased package. Additional revisions may incur additional charges.

7. Disclaimer of Warranties

Services are provided "as is" without warranties of any kind. Final results may vary depending on the quality of submitted recordings.

8. Limitation of Liability

The service provider shall not be liable for indirect, incidental, or consequential damages, including loss of profits, distribution issues, or business interruption.

9. Termination

This Agreement may be terminated if the user violates its terms. Upon termination, license rights granted under this Agreement may be revoked.

10. Governing Law

This Agreement shall be governed by and interpreted in accordance with applicable laws in the jurisdiction where the service provider operates.

11. Modifications

We reserve the right to modify this Agreement at any time. Continued use of services constitutes acceptance of any updated terms.
