

# Terms of Service

## 1. Agreement to Terms

By accessing or using 0xLabs ("Service"), you agree to be bound by these Terms of Service ("Terms"). If you do not agree to these Terms, please do not use the Service.

These Terms apply to all visitors, users, and others who access or use the Service. By using the Service, you represent that you are at least 18 years of age and have the legal authority to enter into these Terms.

## 2. Description of Service

0xLabs provides automated GitHub security monitoring services that scan organizations for exposed secrets, API keys, credentials, and other sensitive information. Our Service includes:

- Continuous GitHub organization monitoring
- Secret and credential detection
- Real-time notifications via Discord
- Security dashboard and reporting
- PDF security reports

## 3. Account Registration

To use certain features of the Service, you may be required to provide information about yourself and/or your organization. You agree to provide accurate, current, and complete information during the registration process.

You are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account.

## 4. Subscription Plans and Payment

### 4.1 Plans

We offer multiple subscription plans including Free, High Severity, and Critical Severity tiers. Each plan provides different features and capabilities as described on our pricing page.

### 4.2 Payment

Paid subscriptions are billed annually. By subscribing to a paid plan, you authorize us to charge your payment method for the applicable fees.

### **4.3 Refunds**

- High Severity Plan: \$150 setup fee is non-refundable (max refund: \$549)
- Critical Severity Plan: \$200 setup fee is non-refundable (max refund: \$699)
