

# Privacy Policy

This Privacy Policy describes how **Tamara Peklic** ("we", "our", or "us") collects, uses, and protects your personal information when you purchase, access, or interact with our digital products, services, websites, or online communities.

This information may be collected when you:

- Contact us for support

## **Why We Process Your Data**

We process your information only when necessary to operate our business and provide our services. This may include:

- Processing purchases and payments

- Complying with legal obligations
