Erika Chaubert T/A GLP-1 Adapt (“we”, “us”, or “our”) respects your privacy and is committed to protecting your personal data. This Privacy Policy will inform you as to how we look after your personal data when you visit our website (glp1adapt.com) and tell you about your privacy rights and how the law protects you.

1. Information We Collect

We may collect, use, store and transfer different kinds of personal data about you which we have grouped together as follows:

- **Identity Data:** includes first name, last name, username or similar identifier.
 - **Contact Data:** includes billing address, delivery address, email address and telephone numbers.
 - **Financial and Transaction Data:** includes details about payments to and from you and other details of products and services you have purchased from us. *Note: All payment processing is handled securely by our third-party payment processor, Whop. We do not store your full credit card details.*
 - **Technical Data:** includes internet protocol (IP) address, your login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access this website.

2. How We Collect Your Data

We use different methods to collect data from and about you including through:

- **Direct interactions:** You may give us your Identity, Contact and Financial Data by filling in forms or by corresponding with us by post, phone, email or otherwise. This includes personal data you provide when you purchase our products.
 - **Automated technologies or interactions:** As you interact with our website, we will automatically collect Technical Data about your equipment, browsing actions and patterns. We collect this personal data by using cookies, server logs and other similar technologies.

3. How We Use Your Data

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- Where we need to perform the contract we are about to enter into or have entered into with you (e.g., delivering the digital product).
 - Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.
 - Where we need to comply with a legal obligation.

4. Disclosures of Your Personal Data

We may share your personal data with external third parties, including:

- **Payment Processors:** such as Whop, to process your transactions securely.
 - **Service Providers:** acting as processors who provide IT and system administration services.
 - **Professional Advisers:** acting as processors or joint controllers including lawyers, bankers, auditors and insurers.

5. Data Security

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed.

6. Data Retention

We will only retain your personal data for as long as reasonably necessary to fulfil the purposes we collected it for.

7. Your Legal Rights

Under certain circumstances, you have rights under data protection laws in relation to your personal data, including the right to request access, correction, erasure, restriction, transfer, or to object to processing. If you wish to exercise any of these rights, please contact us.
