■ END USER LICENSE AGREEMENT — READ CAREFULLY BEFORE USING THE SOFTWARE. BY INSTALLING OR USING LOCAL TRADING JOURNAL YOU AGREE TO THE TERMS OF THIS AGREEMENT.

1. Grant of License

Subject to the terms of this Agreement, the Seller grants you a limited, non-exclusive, non-transferable, revocable license to install and use Local Trading Journal ("the Software") on devices that you own or control, solely for your own personal trading journaling purposes.

2. Restrictions

You may NOT:

- X Copy, distribute, sell, sublicense, or transfer the Software or your license to any third party
- X Share the Software files publicly or privately with any person who has not purchased a license
- X Use the Software to build a competing product
- X Remove or alter any proprietary notices or labels on the Software
- X Claim authorship of the Software

3. Ownership

The Software is licensed, not sold. The Seller retains all intellectual property rights, title, and interest in and to the Software. This Agreement does not grant you any ownership rights.

4. As-Is — Disclaimer of Warranties

■ THE SOFTWARE IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND. THE SELLER EXPRESSLY DISCLAIMS ALL WARRANTIES, WHETHER EXPRESS, IMPLIED, STATUTORY OR OTHERWISE, INCLUDING WITHOUT LIMITATION ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

The Seller does not warrant that the Software will meet your requirements, operate without interruption or error, or be compatible with your version of Obsidian or operating system.

5. No Updates Obligation

The Seller may provide updates at their sole discretion and is under **no obligation** to do so. This EULA does not entitle you to any future updates, new features, bug fixes, or technical support.

This Agreement is effective until terminated. Your rights will terminate automatically without notice if you fail to comply with any of its terms. Upon termination you must destroy all copies of the Software in your possession.

9. Entire Agreement
