1. Introduction

Framer Templates By Jalal Eddine ("we," "us," or "our") operates through the Whop platform (whop.com). This Privacy Policy explains how we handle information in connection with the sale of our digital products (Framer website templates).

2. Information We Collect

We do not directly collect personal information. All purchases are processed through the **Whop platform**, which handles:

- Your name and email address (for order fulfillment and communication)
- Payment information (processed securely by Whop's payment infrastructure)
- Transaction records (order history, purchase amounts)

We may have access to your name, email, and purchase history through the Whop seller dashboard for customer support purposes.

3. How We Use Your Information

Any information accessible to us is used solely for:

- Delivering your purchased Framer template(s)
- Providing customer support related to your purchase
- Communicating important updates about your purchased product(s)

We do **not** sell, rent, or share your personal data with third parties for marketing purposes.

4. Data Security
