### 4. Subscription and Payment

Access to Profit Raiders content is provided on a subscription basis through Whop. By subscribing:

- You authorize us to charge the applicable subscription fee to your payment method.

- All payments are processed securely through Whop's payment infrastructure.

### 5. No Refund Policy & Cancellation
