

# PROFIT RAIDERS END USER LICENSE AGREEMENT (EULA)

Effective Date: April 19, 2026

This End User License Agreement ("Agreement") is a legal agreement between you ("User") and Profit Raiders ("Company") governing your use of the Profit Raiders service, content, signals, and associated materials ("Content"). By accessing the Service, you agree to be bound by this Agreement.

## 1. License Grant

All Content, including trading signals, analysis, commentary, graphics, logos, and branding, is and remains the exclusive property of Profit Raiders. This Agreement does not transfer any ownership rights to you.

## 4. No Refunds — Cancellation Is Your Responsibility

Profit Raiders operates a strict **no refund policy**. All sales are final. Due to the digital and time-sensitive nature of trading signals, analysis, and educational content, we are unable to offer refunds once access has been granted.

**The only exceptions** are cases where a charge was made **by mistake** or you were **double charged** for the same billing period.
