

BOOKIE BANDIT BOT PRIVACY POLICY

Last Updated: March 18, 2026

Users are required to review the Refund Policy, End User License Agreement (EULA), Privacy Policy, and these Terms of Service in their entirety before using the Software.

1. INTRODUCTION

Analog Software Inc. ("we," "us," or "our") values your privacy and is committed to protecting your personal information. This Privacy Policy explains **how we collect, use, share, and protect** personal data in connection with the **Bookie Bandit Software ("the Bot" or "our services")**.

By using our services, you agree to the terms of this Privacy Policy. If you do not agree, **do not use Bookie Bandit**.

Relationship to Other Agreements: Your use of the Bot is also governed by our separate Terms of Service (TOS) and the End-User License Agreement (EULA). In the event of a conflict between those documents and this Privacy Policy, the TOS and EULA will generally govern your conduct and liability.

1.1 Definitions

For the purpose of this document, "Sportsbook" or "Sportsbooks" is defined broadly to include, but is not limited to, Daily Fantasy Sports (DFS) apps, sweepstakes platforms, betting exchanges, prediction markets, and traditional regulated sports betting platforms. All definitions shall be construed to extend to all forms, tenses, capitalizations, and conjugations of the defined word.

2. INFORMATION WE COLLECT

2.1 Personal Information

We collect certain **personal information** when you interact with Bookie Bandit, including:

- Name
- Mobile Phone Number
- Email address

- Payment information (processed through Whop, not stored by us)
- User account credentials (for Bookie Bandit, not sportsbook logins)

Our Commitment to Data Minimization: We adhere to the principle of data minimization, meaning we only collect personal information that is strictly necessary to provide, maintain, and improve the Bookie Bandit Software and for legal compliance.

2.2 Usage Data

We automatically collect certain information about how you interact with the Software, including:

- IP address
- Device type and operating system
- Browser type and version
- Log data and timestamps
- Usage statistics and feature interactions

2.3 Betting Data (Stored for Analytics Purposes)

To improve **user analytics and background research**, Bookie Bandit **stores** betting-related data, including:

- Bets placed using Bookie Bandit (outcomes, timestamps, amounts)
- Wagering history for analytics and performance tracking
- Statistical data on user interaction with automation features

What we DO NOT collect:

- Sportsbook login credentials
- Personally identifiable financial details

2.4 SMS and Mobile Communication Data

- Opt-in forms on our website(s).
- Lead generation forms via Facebook/Meta Ads and Google Ads.
- Promotional materials where you explicitly check a box or enter your number to subscribe.

By providing your phone number in these forms, you consent to receive text messages from us.

3. HOW WE USE YOUR INFORMATION

We use the information collected for the following purposes:

- Providing and maintaining services (ensuring Bookie Bandit functions as intended)
- Processing payments and subscriptions (via Whop)
- User experience improvements (enhancing automation and analytics)
- Software performance analysis (understanding betting trends and tool effectiveness)
- Ensuring compliance with our EULA and applicable laws
- Legal compliance (meeting regulatory obligations where required)
- Sending service notifications and promotional updates via SMS/text messaging (only to users who have opted in)

Bookie Bandit **does not sell, rent, These third-party vendors fall into the following categories or trade personal data** to third parties for advertising or marketing purposes.

4. INFORMATION SHARING AND DISCLOSURE

We may **share** information in the following cases:

4.1 With Service Providers and Partners

We work with **third-party vendors** (e.g., Whop for payments) who process limited personal data strictly for providing services.

These third-party vendors fall into the following categories:

- **Payment Processing:** (e.g., Whop) for managing subscriptions and billing
- **Cloud Hosting & Infrastructure:** For secure data storage and ensuring the Bot's uptime.
- **Analytics Providers:** For tracking usage data to improve the software and user experience
- **Customer Support Platforms:** (e.g., Whop) For managing user inquiries and customer communications

4.2 Legal Compliance and Protection

We may disclose your information if required:

- To comply with legal obligations (court orders, government requests)
- To enforce our Terms of Service and EULA
- To prevent fraud, abuse, or security threats

4.3 Business Transactions

If Bookie Bandit is **acquired, merged, or undergoes a business transaction**, user data may be transferred **as part of the transition**.

We do not sell, rent, or trade personal data to third parties for advertising or marketing purposes. **Specifically, mobile information and text messaging originator opt-in data and consent will not be shared with any third parties or affiliates for their marketing/promotional purposes.**

5. DATA SECURITY

We implement **reasonable security measures** to protect your personal information, including:

- Encryption protocols for data transmission
- Restricted access to sensitive data
- Internal security audits for software and servers

However, no system is **100% secure**. You are responsible for protecting your own devices and passwords.

5.1 International Data Transfer

Your personal information may be stored and processed in any country where we have facilities or where we engage service providers. By using the Bot, you understand that your data may be transferred to countries outside of Canada, including the United States, which may have different data protection laws than your country of residence. We will take all reasonable steps to ensure that your data is treated securely and in accordance with this Privacy Policy.

6. DATA RETENTION

We retain your **personal information**:

- For as long as necessary to provide our services

- To comply with legal obligations
- To improve system analytics and automation

Once your account data deletion is processed, or when personal information is no longer needed to provide services, we reserve the right to retain all betting and usage data in a de-identified and aggregated form. This de-identified data is used solely for ongoing product improvement, analytics, and historical research and cannot be reasonably linked back to you.

7. USER RIGHTS

Depending on your jurisdiction, you may have the following rights:

- **Access** – Request a copy of the personal data we have about you
- **Correction** – Update inaccurate or incomplete information
- **Deletion** – Request that we delete your personal data (subject to legal retention limits)
- **Restriction of Processing** – Limit how we use your data
- **Data Portability** – Request data in a structured format
- **SMS Opt-Out:** You have the right to unsubscribe from SMS/text messaging at any time by replying "STOP" to any message you receive from us or by contacting us directly.

Bookie Bandit **may use cookies** or tracking technologies to:

- Remember user preferences
- Analyze website traffic and software usage trends

We may update this Privacy Policy **from time to time**. We will provide notice of significant changes by:

- Posting the revised Privacy Policy on our website
- Updating the “Last Updated” date at the top

Continued use of Bookie Bandit after changes **constitutes acceptance of the updated policy.**

10. CHILDREN'S PRIVACY

Bookie Bandit is **not intended for users under the age of 19.** We do not knowingly collect data from minors.

If we discover that a minor has provided personal data, we will **delete it immediately.**
