

# BOOKIE BANDIT TERMS OF SERVICE

**Last updated:** March 18, 2026

Users are required to review the Refund Policy, End User License Agreement (EULA), Privacy Policy, and these Terms of Service in their entirety before using the Software.

## BACKGROUND

Bookie Bandit is an automated sports betting software designed for research, data analysis, and entertainment purposes. Bookie Bandit, Bookie Bandit Lite, and Bookie Bandit Pro are wholly owned by Analog Software Inc. Bookie Bandit is an interchangeable term for both Bookie Bandit, and Bookie Bandit Pro henceforth.

Bookie Bandit is not a bookmaker, sportsbook, or gambling operator. It is a third-party automation tool that operates exclusively on licensed and legal betting platforms. Users acknowledge that Bookie Bandit does not offer gambling services, set odds, or process bets; it only facilitates browser-based automation for user-executed betting decisions.

By using Bookie Bandit, you agree to Whop's Terms of Service and the terms of any sportsbook or betting platform you choose to interact with. Users also acknowledge that they may be required to use Discord and comply with its terms of service.

For the purpose of this document, "Sportsbook" or "Sportsbooks" is defined broadly to include, but is not limited to, Daily Fantasy Sports (DFS) apps, sweepstakes platforms, betting exchanges, prediction markets, and traditional regulated sports betting platforms. All definitions shall be construed to extend to all forms, tenses, capitalizations, and conjugations of the defined word.

## 1. ACCEPTANCE OF TERMS

PLEASE READ THE FOLLOWING TERMS CAREFULLY.

By clicking "I Accept," or by downloading, installing, or otherwise using Bookie Bandit, you confirm that you have read, understood, and agreed to be bound by these Terms of Service ("Terms").

If you do not agree to these Terms, you are not permitted to use Bookie Bandit.

## 2. DESCRIPTION OF SERVICE

Bookie Bandit is an automated, research-based betting assistant that allows users to analyze and execute betting strategies on legal sportsbooks through browser automation.

### What Bookie Bandit is NOT:

- For the purpose of this section, "Sportsbook" or "Sportsbooks" is defined broadly to include, but is not limited to, Daily Fantasy Sport, sports books, sportsbooks, social books, sweepstakes, prediction markets, exchanges etc. All definitions shall be construed to extend to all forms, tenses, capitalizations, and conjugations of the defined word.
- Bookie Bandit is not a bookmaker, sportsbook, or gambling operator. All definitions shall be construed to extend to all forms, tenses, capitalizations, and conjugations of the defined word.
- Bookie Bandit does not process bets, accept wagers, or provide financial transactions.
- Bookie Bandit does not guarantee betting results or profits.

### What Bookie Bandit DOES:

- Offers technology to facilitate the placement of user-executed betting decisions on licensed sportsbooks, comparable to executing an action via a share link.
- Collects and stores betting data for analytics purposes to enhance performance tracking and research.
- Operates independently from all sportsbooks and does not have affiliations with any betting platform.
- **Facilitation Only:** The User acknowledges that Bookie Bandit does not place bets on their behalf. Instead, the User utilizes the Company's technology to display bets, but it is the User who legally places the bet.

## 3. ELIGIBILITY

### 3.1 Age Requirement:

Use is restricted to individuals of legal gambling age in their jurisdiction (typically 18+, 19+, or 21+ depending on your state or province). Users are responsible for complying with all local laws and regulations. We do not promote or condone illegal gambling.

### 3.2 Legal Compliance:

Users must ensure their use of Bookie Bandit complies with their local gambling laws and the terms of their sportsbook. The Company is not responsible for any violations of sportsbook policies or regional gambling laws by users.

## 4. USER ACCOUNT

**4.1 Security Responsibility:** Users are solely responsible for maintaining the confidentiality of their account credentials (both for Bookie Bandit and any third-party sportsbooks). **You acknowledge that by providing sportsbook account credentials to the Software, you assume all risks associated with the security of those accounts.** Analog Software Inc. is not responsible for any breaches, unauthorized access, or misuse of the User's third-party accounts, including any financial losses incurred.

### 4.2 Account Use:

- You may not share your account credentials or grant access to unauthorized users.
- Analog Software Inc. is not liable for unauthorized access caused by user negligence.

## 5. SUBSCRIPTION AND PAYMENTS

### 5.1 Subscription Plans:

Bookie Bandit offers the following plans:

- Bi-weekly plan
- Monthly plan
- Yearly plan

## **5.2 Automatic Renewal:**

All subscription fees are non-refundable except as specified in the Refund Policy.

## **7.1 Data Storage for Analytics:**

Users acknowledge that Bookie Bandit stores bet-related data for:

- Performance analytics
- Enhancing the software's background analytics capabilities
- Research and product improvements

## **7.2 Scope of Stored Data:**

- We do NOT store user credentials, personal financial information, or sportsbook login details.
- Stored data is limited to bet details, timestamps, and aggregated performance metrics.

## **7.3 Data Retention & Usage:**

Bookie Bandit retains stored data for internal research and analysis purposes. Users expressly consent to this data usage by accepting these Terms.

## **7.4 No Data Selling:**

We do not sell, rent, or share user data with third parties for marketing purposes.

## **8.1 Service Provided "As-Is":**

Bookie Bandit is provided as-is and as available, without warranties of any kind.

## **8.2 No Guarantee of Results:**
