1. Introduction & Acceptance of Terms

Welcome to **6 Figure Ecom Bot**. These Terms of Service ("Terms") govern your access to and use of our AI-powered ecommerce store builder, all related services, digital products, and any content delivered through the Whop platform (collectively, the "Service").

The Service is designed to streamline and automate the store-building process. Customers follow a simple setup guide, and the AI handles the technical build. The entire setup process takes approximately 10 minutes.

3. Account Terms

- You must be at least **18 years of age** (or the age of majority in your jurisdiction) to purchase or use the Service.
- You are responsible for maintaining the confidentiality and security of your account credentials, including your Whop login information.
- You are solely responsible for all activity that occurs under your account.
- You must provide accurate, current, and complete information when creating your account and making purchases.
- You agree to notify us immediately of any unauthorized use of your account or any other breach of security.
- We reserve the right to suspend or terminate accounts that violate these Terms.
