

Super Sellers – Terms of Service & Membership Agreement

By purchasing a membership via **Whop** and joining the **Super Sellers Discord**, you (the "Member") agree to the following terms. These terms constitute a legally binding agreement between the Member and Super Sellers.

1. Digital Access & Whop Fulfillment

- **Instant Delivery:** Upon successful payment via Whop, access to the Discord community and its resources is granted immediately. This constitutes full delivery of the digital product.
- **Subscription Management:** Members are responsible for managing their subscriptions, cancellations, and payment methods through their **Whop Dashboard**.

2. Strict No-Refund & Chargeback Policy

- **Final Sale:** All membership fees, whether monthly, quarterly, or annual, are **non-refundable (Final Sales)**.
- **Digital Nature:** Due to the proprietary nature of the leads, templates, and intellectual property provided, no refunds will be issued once access to the Discord or Whop hub has been granted.
- **Dispute Protection:** Super Sellers and Whop track member activity (login data, message history, and file downloads). In the event of a stripe or bank dispute/chargeback, this data will be submitted as evidence of service consumption.
- **Expulsion:** Violating community rules (Section 3 & 4) that results in expulsion does **not** entitle the member to a refund of any remaining subscription time.

3. Intellectual Property & Confidentiality

- **Proprietary Information:** All leads, outreach templates, supplier data, and internal strategies shared within Discord are the exclusive property of Super Sellers.
- **Anti-Leaking Clause:** Sharing, selling, or distributing any internal content to non-members is strictly prohibited. Any member found leaking information will be **immediately banned** from both Whop and Discord without notice and without refund.
- **Content Rights:** Super Sellers reserves the right to use screenshots of community wins, discussions, or shared images for promotional purposes on social media.

4. Community Code of Conduct (Discord Rules)

- **Professionalism:** Harassment, hate speech, or derogatory comments regarding race, religion, orientation, or gender will result in an immediate ban.
- **No Spam/Self-Promotion:** External links, self-promotion, and irrelevant spam are prohibited. Members should "give more than they take."
- **Channel Discipline:** The "Leads" channels are strictly for data. Questions must be directed to the General Chat. Use the "Search" function before asking frequently answered questions.
- **Admin Authority:** Link sharing requires prior Admin approval. Admins reserve the right to remove any member who disrupts the community environment.
