

Profit Pioneers Privacy Policy

Effective Date: March 16, 2026

1. Scope

This Privacy Policy explains how Profit Pioneers ("Profit Pioneers," "we," "us," or "our") collects, uses, stores, and shares information when you access or use our community, Discord server, websites, tools, alerts, software, lead channels, digital content, and related services (collectively, the "Services"). By using the Services, you agree to the practices described in this Privacy Policy.

2. Information We May Collect

Depending on how you interact with the Services, we may collect information such as your name, username, Discord username, email address, billing details, payment status, transaction history, support messages, server activity, usage data, device or browser information, and other information you choose to provide to us.

3. Payment Information

Payments may be processed by third-party payment processors or platforms. We may receive payment-related details such as billing status, transaction IDs, plan type, renewal status, and partial payment method details, but we do not need to store full payment card information ourselves unless specifically provided through an approved payment workflow.

4. How We Use Information

We may use information we collect to operate the Services, provide access, manage memberships, process transactions, deliver support, communicate with users, prevent fraud or abuse, enforce our Terms, improve our tools and community experience, maintain security, and comply with legal obligations.

5. Community and Platform Data

Because Profit Pioneers may operate through Discord and other third-party platforms, certain information may also be collected, processed, or stored by those third parties under their own terms and privacy policies. Your use of those platforms is also subject to the policies of those third parties.

6. Sharing of Information

We may share information with service providers, payment processors, hosting providers, software vendors, moderators, contractors, professional advisors, legal authorities, or other parties when reasonably necessary to operate the Services, enforce our rules, protect rights or safety, investigate misconduct, comply with law, or complete business operations. We do not share information beyond what is reasonably necessary for these purposes.

7. User Content and Communications

If you post messages, uploads, screenshots, reviews, testimonials, suggestions, or other content within Profit Pioneers, we may access, review, use, and retain that content for moderation, operational, support, educational, promotional, dispute-resolution, or security purposes, subject to applicable law.

8. Data Retention

We may retain information for as long as reasonably necessary to provide the Services, maintain records, enforce agreements, resolve disputes, prevent fraud, comply with legal obligations, or protect the security and integrity of Profit Pioneers. Retention periods may vary depending on the type of information and the purpose for which it was collected.

9. Security

We take reasonable administrative, technical, and operational measures to protect information, but no method of transmission, storage, or platform security is guaranteed to be completely secure. You are responsible for maintaining the confidentiality of your own accounts, passwords, devices, and connected platform credentials.

10. Children

The Services are not directed to children under 13, and we do not knowingly collect personal information from children under 13 through the Services.

11. Your Choices

You may be able to update certain account information, leave the community, cancel recurring subscriptions before renewal, or contact us regarding certain privacy-related questions. If you choose not to provide certain information, some parts of the Services may not function properly or may be unavailable.

12. Third-Party Links and Services

The Services may contain links to third-party websites, retailers, apps, tools, or platforms. We are not responsible for the privacy practices, security, content, or policies of third parties.

13. Changes to This Policy

We may update this Privacy Policy from time to time. Updated versions become effective when posted or otherwise communicated through the Services unless stated otherwise. Your continued use of the Services after an update constitutes your acceptance of the revised Privacy Policy.
