

Profit Pioneers End User License Agreement (EULA)

Effective Date: March 16, 2026

This End User License Agreement ("EULA") is a legal agreement between you and Profit Pioneers ("Profit Pioneers," "we," "us," or "our") governing your access to and use of any Profit Pioneers software, bots, tools, checkers, alerts, automations, scripts, calculators, integrations, dashboards, and related digital functionality (collectively, the "Software").

By accessing, downloading, installing, connecting to, purchasing, or using the Software, you agree to this EULA. If you do not agree, do not use the Software.

1. License Grant

Subject to your compliance with this EULA, we grant you a limited, revocable, non-exclusive, non-transferable, non-sublicensable license to access and use the Software for your personal internal business use only.

2. No Ownership Transfer

The Software is licensed, not sold. Profit Pioneers retains all right, title, and interest in and to the Software, including all code, logic, systems, methods, designs, workflows, databases, alerts, and related intellectual property.

3. Restrictions

You may not:

- copy, reproduce, distribute, sell, lease, sublicense, or transfer the Software;
- share access with any other person;
- reverse engineer, decompile, disassemble, or attempt to extract source code;
- clone, scrape, mirror, or recreate the Software or its outputs;
- bypass security, licensing, payment, access, or technical restrictions;
- use the Software to build a competing product or service;
- exploit bugs, vulnerabilities, or unintended functionality; or
- use the Software for unlawful, fraudulent, abusive, or harmful purposes.

4. Account Responsibility

You are responsible for maintaining the confidentiality and security of any account, login, integration, API connection, or access credential used with the Software. You are responsible for all activity occurring through your account or credentials.

5. Updates and Changes

We may modify, update, suspend, limit, or discontinue any part of the Software at any time, with or without notice. We do not guarantee that any feature, function, integration, or output will remain

available.

6. Term and Termination

This EULA remains effective until terminated. We may suspend or terminate your access immediately, with or without notice, if you violate this EULA, violate our Terms of Service, fail to make payment, misuse the Software, leak content, share access, or engage in conduct harmful to Profit Pioneers.

Upon termination, your license ends immediately and you must stop using the Software.

7. Intellectual Property

All rights not expressly granted are reserved by Profit Pioneers. The Software and all related intellectual property remain the exclusive property of Profit Pioneers or its licensors.

8. No Warranties

10. Governing Law

This EULA is governed by the laws of the State of Colorado, without regard to conflict of law principles. Any dispute arising from or relating to this EULA shall be brought exclusively in the state or federal courts located in Colorado.

11. Entire Agreement

This EULA supplements the Profit Pioneers Terms of Service. If there is a conflict between this EULA and the Terms of Service regarding software use, this EULA controls for the Software-related issue.
