

END USER LICENSE AGREEMENT (EULA)

By purchasing, subscribing to, accessing, downloading, viewing, participating in, or otherwise using any product, service, software, digital content, educational material, community access, platform feature, tool, indicator, methodology, recording, live or recorded session, or related offering made available by DELFI TRADING, the customer expressly acknowledges and agrees that such access and use is granted solely pursuant to a limited, revocable, non-exclusive, non-transferable, non-sublicensable license for personal, internal, non-commercial use only, that no sale, assignment, or transfer of ownership or intellectual property rights occurs under any circumstances, that all content and materials remain the exclusive property of DELFI TRADING and are protected by applicable intellectual property laws, and that the act of submitting payment constitutes full consideration for the license granted, full performance and fulfillment by DELFI TRADING, and a final, binding, and conclusive transaction, irrespective of whether the licensed materials are accessed, activated, reviewed, utilized, downloaded, streamed, attended, delayed, restricted, misunderstood, ignored, unused, partially used, fully used, suspended, revoked, or terminated, with the customer further acknowledging and agreeing that, as a condition of purchase and licensure, no refund, partial refund, credit, exchange, reversal, reimbursement, or monetary recovery of any kind shall be issued or available under any circumstances whatsoever, and that the customer permanently, knowingly, and voluntarily waives any and all rights, claims, demands, remedies, or expectations to recover funds under any legal, contractual, statutory, regulatory, equitable, consumer-protection, or common-law theory, including but not limited to dissatisfaction, change of mind, buyer's remorse, accidental or mistaken purchase, failure to read or understand descriptions or disclosures, technical incompatibility, access issues attributable to the customer, financial hardship, lack of results, perceived value disputes, subjective expectations, market conditions or volatility, account suspension or termination, policy enforcement, subscription renewal oversight, billing misunderstandings, third-party platform limitations, or any asserted cooling-off period, grace period, rescission right, or reconsideration window, none of which shall apply, and the customer further agrees that the licensed materials are provided solely for educational and informational purposes without any guarantees of performance, profitability, income, or results, that all decisions and actions taken in reliance thereon are the customer's sole responsibility, that DELFI TRADING disclaims all warranties to the maximum extent permitted by law and provides the licensed materials on an "as is" and "as available" basis, that DELFI TRADING may suspend or terminate the license and access at any time for any reason including violation of policies or initiation of a chargeback or dispute, that initiating a chargeback or payment dispute constitutes a breach of the agreement and may result in permanent termination without reinstatement, that DELFI TRADING may contest disputes using transaction records and access logs, that DELFI TRADING shall not be liable for any indirect, incidental, consequential, special, or punitive damages and that any total liability shall not exceed the amount paid by the customer, that this agreement is governed by the laws of the State of California with exclusive venue therein, that any unenforceable provision shall be severed without affecting the remainder, and that by completing payment or accessing the licensed materials the customer affirms that they have read, understood, and agreed to be legally bound by all of the foregoing terms in their entirety.
