

PRIVACY POLICY

This Privacy Policy describes how DELFI TRADING collects, uses, stores, processes, protects, and discloses information obtained from individuals who access, purchase, subscribe to, interact with, or otherwise use any websites, platforms, applications, software, content, communities, products, services, tools, educational materials, or related offerings made available by DELFI TRADING, and by using or accessing any such offerings the user acknowledges and agrees that information may be collected directly through user submissions, automatically through technological means, or indirectly through third-party service providers, payment processors, analytics platforms, hosting providers, and communication tools, including but not limited to personal identifiers such as name, email address, account credentials, billing details, transaction records, communications, support inquiries, and any other information voluntarily provided, as well as technical and usage data such as IP addresses, device identifiers, browser and operating system information, timestamps, access logs, interaction history, subscription status, cookies, pixels, and similar tracking technologies, all of which may be used for purposes including providing, maintaining, and improving services, processing payments, managing access, communicating with users, analyzing usage patterns, monitoring compliance with policies, detecting and preventing fraud or abuse, enforcing contractual agreements, responding to legal obligations, protecting the security and integrity of systems, and conducting internal business operations, with such information being retained for as long as reasonably necessary to fulfill these purposes, comply with applicable laws, resolve disputes, and enforce rights, and while DELFI TRADING does not sell personal information it may share or disclose information with trusted third parties such as payment processors, hosting providers, analytics services, professional advisors, regulatory authorities, or successor entities in the event of a merger, sale, or restructuring, subject to confidentiality and data protection obligations, and users further acknowledge that information may be transferred to and processed in jurisdictions outside their place of residence which may have different data protection standards, that reasonable administrative, technical, and organizational safeguards are implemented to protect information though absolute security cannot be guaranteed, that users are responsible for maintaining the confidentiality of their account credentials and the accuracy of information provided, that certain rights regarding access, correction, deletion, restriction, or objection to processing may be available depending on jurisdiction and subject to verification and legal limitations, that the services are not intended for individuals under the age of eighteen and no information is knowingly collected from minors, that DELFI TRADING may monitor usage and access for security, compliance, and enforcement purposes, that information may be disclosed as required to comply with legal process or protect rights, property, or safety, that third-party platforms or links accessed through the services are governed by their own privacy practices, that this Privacy Policy may be modified at any time with updates becoming effective upon posting, that continued use of the services constitutes acceptance of any revised terms, and that this Policy shall be governed by the laws of the State of California, with users acknowledging by their continued access or use that they have read, understood, and agreed to the collection, use, processing, and disclosure of information as described herein.
