By using the Services, you agree to the collection and use of information in accordance with this Privacy Policy. If you do not agree, do not use the Services.

1. Scope of This Privacy Policy

This Privacy Policy applies to information collected through: (a) our website at www.investorsemester.com; (b) our Discord server and community channels; (c) our content, trainings, workshops, and events; and (d) our checkout and billing provider Whop.com and related access systems (collectively, the "Services").

This Privacy Policy does not apply to third-party websites, platforms, or services that we do not control (such as Discord or Whop), even if they are used to deliver the Services. Those providers' privacy policies also apply.

2. Information We Collect

We may collect the following types of information:

Personal Information. When you register or purchase a subscription, we may collect personal information such as your name, email address, payment information, and any other details you provide. Examples may include: name, email, phone number (if provided), Discord username/handle, billing address (if provided through the payment processor), and information you submit in forms, surveys, or messages.

Usage Data. We may collect information about how you access and use our Services, including your IP address, browser type, and device information. This can include log data such as pages viewed, referring/exit pages, date/time stamps, clicks, and similar diagnostic data.

Cookies. We may use cookies and similar tracking technologies to enhance your experience on our platform. We may use cookies, pixels, and similar technologies to remember preferences, understand usage, and improve performance. You can control cookies through your browser settings. Some features may not work properly if cookies are disabled.

Payment Information. While we may receive limited transaction details (such as purchase status, plan type, and the last four digits of a payment method, where applicable), payment processing is handled by Whop.com and/or their payment processors. We do not store full payment card numbers.

Community Content and Communications. If you post messages, files, or other content in Discord or communicate with us (email, chat, tickets), we may collect and store those communications and any information you choose to provide.

3. How We Use Your Information

We may use the information we collect for various purposes, including:

- To provide, operate, and maintain our Services.
- To process your transactions and manage your subscriptions.
- To communicate with you, including sending updates and promotional materials.
- To improve our Services and enhance user experience.
- To monitor usage and analyze trends to improve our platform.

We may also use information to: (a) troubleshoot problems; (b) enforce our Terms of Service and community rules; (c) prevent fraud, abuse, and unauthorized access; (d) comply with legal obligations; and (e) protect the rights, property, and safety of us, our users, and others.

Marketing Communications. You can opt out of marketing emails at any time by using the unsubscribe link in the email. Transactional messages (billing, access, important service notices) are not marketing and may still be sent.

4. Sharing Your Information

We do not sell or rent your personal information to third parties. We may share your information in the following circumstances:

With Service Providers. We may share your information with third-party service providers that assist us in operating our Services, such as payment processors like Whop.com. This may include service providers for payment processing (Whop.com and their processors), community hosting (Discord), email/support tools, analytics, security, and infrastructure.

For Legal Reasons. We may disclose your information if required to do so by law or in response to valid requests by public authorities. We may also disclose information to enforce agreements, investigate potential violations, respond to claims, protect our rights or safety (or the rights/safety of others), and prevent fraud or security issues.

Business Transfers. If we are involved in a merger, acquisition, financing, reorganization, or sale of some or all assets, information may be transferred as part of that transaction subject to standard confidentiality protections.

We do not sell personal information. We do not knowingly share personal information for cross-context behavioral advertising as those terms may be defined under applicable privacy laws. If that changes, we will update this Privacy Policy and provide any required opt-out mechanisms.

5. Data Retention

We retain personal information only as long as reasonably necessary to provide the Services, maintain business records, comply with legal obligations, resolve disputes, and enforce agreements. Retention periods vary depending on the type of data and the purpose for which it is collected.

6. Data Security

We implement reasonable security measures to protect your personal information from unauthorized access, use, or disclosure. However, no method of transmission over the internet or method of electronic storage is 100% secure, and we cannot guarantee its absolute security.

You are responsible for maintaining the confidentiality of any login credentials and for restricting access to your devices and accounts.

7. Your Rights and Choices

Depending on your jurisdiction, you may have certain rights regarding your personal information, such as:

- The right to access the personal information we hold about you.
- The right to request correction of inaccurate or incomplete information.
- The right to object to or restrict the processing of your information.

You may also have the right to request deletion of certain personal information, subject to legal exceptions (for example, where we must retain certain records for compliance, fraud prevention, or legitimate business purposes).
